The [NP] mention in a rule means that a boat cannot claim (No Protest) against another boat for violating this rule. This amends RCV 60.1(a).

[DP] in a rule means that the penalty for a violation of that rule may, at the jury's discretion, be less than a disqualification.

**Preamble**

**Prevention of violence and incivility**

The FFVoile reminds that sporting events are above all a space for exchanges and sharing and are open and accessible to all.

As such, competitors, their legal representatives and their guests are asked to behave in all circumstances, on land and on the water, in a courteous and respectful manner regardless of the origin, gender or sexual orientation of other participants.

**1 RACE RULES**

The race is governed by:

- 1.1 - the rules as defined in: *The Rules of sailing*.
- 1.2 - National requirements translated into English for non-French-speaking competitors.
- 1.3 - Federal regulations
- 1.4 - Class rules
- 1.5 In case of translation of this NoR, the French text will prevail.

**2 Sailing Instructions (SI)**

- 2.1 The SIs will be available on 05 May 2023 19H00, at the latest, on the SRSP website.
- 2.2 SIs will be displayed according to federal requirement

- 3.2 [DP] [NP] While he's racing, except in an emergency, a vessel shall not transmit nor receive any voice or data informations that are not available to all vessels.

**4 ELIGIBILITY AND REGISTRATION**

- 4.1 The event is open to all FINN class boats
- 4.2 Documents required upon registration:



#### 4.2.1

a) For competitors who hold FFVoile Club License:

- The license must show the “Competition” status (which confirms the medical ability for racing in competition).
- If the license shows either “Adhésion” or “Pratiquant” status, the competitor is requested to present a medical certificate of non-contraindication to the practice of sailing in competition dating back less than one year

b) For competitors who do not hold a FFVoile Club license, regardless of their nationality, they have to present :

- a proof of membership of a World Sailing affiliated National Authority
- a valid proof of civil liability insurance with a minimum coverage of two million Euros
- a medical certificate of non-contraindication to the practice of sailing in competition dating back less than one year (written in French or English).

4.2.2 For the sailing boat:

- the valid gauge or rating certificate when a rule requires its presentation.
- when necessary, authorization to carry advertising.

4.3 Competitors and their eligible boats can register online until the morning of the 6<sup>th</sup> of May 2023.

4.5 To be considered registered for the event, a vessel must meet all registration requirements and pay all fees.

6.1 [DP] [NP] Vessels may be required to display the advertising chosen and provided by the organizing authority.

6.2 [DP] [NP] The organizing authority may provide race bibs that competitors are required to wear as authorized by the World Sailing Advertising Code.

9 **EQUIPMENT CONTROL:** There will be no gauge check.



- 10 LOCATIONS:** the race area is located in the bay of Quiberon right in front of the Kerbourgnec beach and the ENVSN. See: Appendix A.
- 11 REGATTA ROUTES:** they will be of the built route type. They will be described in the SIs
- 12 PENALTY SYSTEM:**  
RCV 44.1 is amended to replace the two-turn penalty with the one-turn penalty.
- 13 SCORING**
- 13.1** 1 race must be completed to validate the competition.
- 13.2** a) When less than 4 races have been validated, the score of a boat will be the total of the scores of all its races.  
b) When more 4 races have been validated, the score of a boat in a series will be the total of the scores of its races excluding its worst score.
- 13.3** Rule A5.3 applies.
- 14 ACCOMPANYING BOATS**  
[DP] Escort boats must be identified by a white pennant.
- 15 BOATS RENTED OR LENT**  
[DP] [NP] A boat rented or loaned may bear letters of nationality or a sailing number which do not comply with its class rules, provided that the race committee has approved its sailing identification before the first race.
- 16 PLACES AT THE PORT**  
[DP] [NP] Boats must remain in their assigned space while in the boat park.
- 17 DATA PROTECTION**
- 17.1 Right to image and appearance:**  
By participating in this competition, the competitor and his legal representatives authorize the SRSP to show at any time (during and after the competition) moving or static photos, films or television recordings, and other reproductions of himself-Even taken during the competition, on any medium and for any use related to said event.
- 17.2 Use of participants' personal data**  
By participating in this competition, the competitor and its legal representative's consent and authorize the FFVoile and its sponsors as well as the organising authority to use and store their personal data free of charge. These data may be published by FFVoile and its sponsors. FFVoile, but also its sponsors may use this data for software development or marketing purposes. In accordance with the General Data Protection Regulation (GDPR), any competitor who has communicated personal data to the FFVoile may exercise its right of access to the data concerning it, have them rectified and, depending on the situation, delete, limit, and oppose it, by contacting dpo@ffvoile.fr or by mail to the registered office of the French Sailing Federation, specifying that the request is related to personal data.
- 18 RISK ASSESSMENT**  
RCV 3 states, "A boat's decision to participate in a race or remain in the race is its sole responsibility." By participating in this event, each competitor accepts and recognizes that sailing is a potentially dangerous activity with inherent risks. These risks include high winds and rough seas, sudden changes in weather, equipment failure, vessel manoeuvring errors, other vessels navigating incorrectly, loss of balance on an unstable surface and fatigue, resulting in an increased risk of injury. The risk of physical and/or physical damage is therefore inherent in the sport of sailing

FFVoile Prescriptions to RRS 2021-2024  
translated for non-francophone competitors

FFVoile Prescription to **RRS 25.1** (*Notice of race, sailing instructions and signals*):

For events graded 4 and 5, standard notices of race and sailing instructions including the specificities of the event shall be used. Events graded 4 may have dispensation for such requirement, after receipt of FFVoile approval, received before the notice of race has been published.

For events graded 5, posting of sailing instructions will be considered as meeting the requirements of RRS 25.1 application.

(\*) FFVoile Prescription to **RRS 64.4** (*Decisions on protests concerning class rules*):

The protest committee may ask the parties to the protest, prior to checking procedures, a deposit covering the cost of checking arising from a protest concerning class rules.

(\*) FFVoile Prescription to **RRS 67** (*Damages*):

Any question or request related to damages arising from an incident occurred while a boat was bound by the Racing Rules of Sailing depends on the appropriate courts and cannot be examined and dealt by a protest committee.

A boat that retires from a race or accepts a penalty does not, by that such action, admit liability for damages.

(\*) FFVoile Prescription to **RRS 70.5** (*Appeals and requests to a national authority*):

The denial of the right of appeal is subject to the written approval of the Fédération Française de Voile, received before publishing the notice of race. This approval shall be posted on the official notice board during the event.

(\*) FFVoile Prescription to **RRS 76.1** (*Exclusion of boats or competitors*):

An organizing authority or race committee shall not reject or cancel the entry of a boat or exclude a competitor eligible under the notice of race and sailing instructions for an arbitrary reason.

(\*) FFVoile Prescription to **RRS 78.1** (*Compliance with class rules; certificates*):

The boat's owner or other person in charge shall, under his sole responsibility, make sure moreover that his boat complies with the equipment and security rules required by the laws, by-laws and regulations of the Administration.

(\*) FFVoile Prescription to **RRS 86.3** (*Changes to the racing rules*):

An organizing authority wishing to change a rule listed in RRS 86.1(a) in order to develop or test new rules shall first submit the changes to the FFVoile, in order to obtain its written approval and shall report the results to FFVoile after the event. Such approval shall be mentioned in the notice of race and in the sailing instructions and shall be posted on the official notice board during the event.

(\*) FFVoile Prescription to **RRS 88.2** (*Changes to prescriptions*):

Prescriptions of the FFVoile shall not be changed in the notice of race and sailing instructions, except for events for which an international jury has been appointed.

In such case, the prescriptions marked with an asterisk (\*) shall not be changed in the notice of race and sailing instructions. (The official translation of the prescriptions, downloadable on the FFVoile website [www.ffvoile.fr](http://www.ffvoile.fr), shall be the only translation used to comply with RRS 90.2(b)).

(\*) FFVoile Prescription to **RRS 91(b)** (*Protest committee*):

The appointment of an international jury meeting the requirements of Appendix N is subject to prior written approval of the Fédération Française de Voile. Such approval shall be posted on the official notice board during the event.
